Petition for Name Change of Adult (over 18 years of age)

-Petitions for name changes are heard in the Courtroom assigned to hear civil motions on Monday, Tuesday and Thursday mornings promptly at 8:45 a.m. Late petitions will not be heard. This is open motions court, so appointments are not needed.

-Petitions must be fully completed and signed prior to presentation.

-There will be a filing fee of \$180 to be paid in the Prothonotary's office immediately after motions court. This is payable by cash, check or credit card. The filing fee to the Prothonotary <u>may be</u> waived if certain income guidelines are met. See the law librarian for more details on the In Forma Pauperis petition. Proof of eligibility is required. Filing fees are subject to change.

-Petitions for a judicial name change may carry the requirement of fingerprinting and advertising in the local newspaper and the local legal journal (administered by the Beaver County Bar Association (724) 728-4888). Fees for the Beaver County Legal Journal (approximately \$124.00), the Beaver County Times (approximately \$194.00) and a fingerprinting fee (\$20.00) cannot be waived. Fees are subject to change.

-You must present at the time of the hearing a civil judgment/lien search for any county you have resided in the past 5 years (except Beaver County which will be obtained by the Court).

-Petitioner must have a present valid photo identification at the time of the hearing.

-No court staff may give legal advice. If you have any questions, you should contact a lawyer. If you need assistance in locating a lawyer you should contact the Beaver County Bar Association Lawyer Referral Service at <u>www.bcba-pa.org</u> or (724) 728-4888.

-If the Petition is denied, the fees will not be reimbursed.

-Petitioner must attach a Certificate of Compliance Form to petition prior to presenting in Civil Motions Court.

-Failure to properly follow the requirements may result in the petition being denied or continued.
