- 2023: Cancel IDIS Activity #2368, CD230502 Patterson Heights ADA/Elevator, with a budget of \$161,185.00 and \$15,000.00 for activity delivery costs. The funds will be reprogrammed to other projects.
- 2023: Cancel IDIS Activity #2369, CD235538 Church of the Redeemed, with a budget of \$150,000.00 and \$4,000.00 for activity delivery costs. The funds will be reprogrammed to other projects.
- 2023: Cancel IDIS Activity #2350, CD232800 Mount Vernon Tenants Association Gas Line, with a budget of \$239,040.00 and \$20,000.00 for activity delivery costs. The funds will be reprogrammed to other projects.
- 2023: IDIS Activity #2347, CD230500 Beaver Falls Ruhe Playground, change the budget amount from \$211,155.00 and \$8,000.00 for activity delivery costs as previously advertised to \$372,340 and \$18,000.00 for activity delivery costs. The project will allow for the purchase and installation of playground equipment and park furnishing; includes ADA-accessible equipment.
