#### Petition for Name Change of Minor (under 18 years of age)

- -Petitions for name changes are heard in the Courtroom assigned to hear civil motions on Monday, Tuesday and Thursday mornings promptly at 8:45 a.m. Late petitions will not be heard. This is open motions court, so appointments are not needed.
- -Petitions must be fully completed and signed prior to presentation. A copy of the minor's birth certificate must be available at the time the Petition is presented and at the time of the hearing. **DO NOT** write the minor's full name in the caption. Instead, use the initials of the minor's first and last name. **DO** use the minor's full name while filling out the body of the petition.
- -There will be a filing fee of \$180 to be paid in the Prothonotary's office immediately after motions court. This is payable by cash, check or credit card. The filing fee to the Prothonotary may be waived if certain income guidelines are met. See the law librarian for more details on the In Forma Pauperis petition. Proof of eligibility is required. Filing fees are subject to change.
- -Petitions for a judicial name change may carry the requirement of fingerprinting and advertising in the local newspaper and the local legal journal (administered by the Beaver County Bar Association (724) 728-4888). Fees for the Beaver County Legal Journal (approximately \$124.00), the Beaver County Times (approximately \$194.00) and a fingerprinting fee (\$20.00) for children thirteen or older cannot be waived. Fees are subject to change. Additional notice requirement applies if both parents are not joint petitioners.
- -Petitioner will have a present valid photo identification at the time of the hearing and have the birth certificate of the minor.
- -No court staff may give legal advice. If you have any questions, you should contact a lawyer. If you need assistance in locating a lawyer you should contact the Beaver County Bar Association Lawyer Referral Service at <a href="https://www.bcba-pa.org">www.bcba-pa.org</a> or (724) 728-4888.
- -If the Petition is denied, the fees will not be reimbursed.
- -Petitioner must attach a Certificate of Compliance Form to petition prior to presenting in Civil Motions Court.
- -Failure to properly follow the requirements may result in the petition being denied or continued.
