

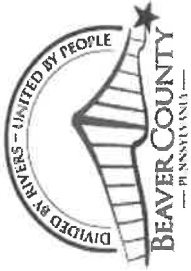
Ms. Roberta Sciuilli, Penn State Extension: Ms. Sciuilli remarked about the positive connections made through Master Gardeners.
